Other Fees & Disclosures:

Late Payment Fee:

\$25.00 or the amount of the required minimum payment, whichever is less, if you are one or more days late in making a payment.

Balance Transfer Fee (Finance Charge):

\$5.00 or 2.00% of the amount of each balance transfer, whichever is greater.

Cash Advance Fee (Finance Charge):

\$5.00 or 2.00% of the amount of each cash advance, whichever is greater.

Returned Payment Fee:

\$10.00 or the amount of the required minimum payment, whichever is less.

Card Recovery Fee:

\$65.00.

Card Replacement Fee:

\$8.00.

Document Copy Fee:

\$15.00 per document.

Emergency Card Replacement Fee:

\$165.00.

Rush Fee:

\$30.00 second day.

Statement Copy Fee:

\$15.00 per document.
