Activate Your New VISA Check Card Now!

Members whose VISA check cards expire from July 2017 thru January of 2019 were sent a new EMV chip card on July 6th.

PLEASE REMEMBER TO ACTIVATE YOUR NEW CARD BY AUGUST 14th. The old swipe card will be deactivated on August 15th and your card access will be denied until the replacement card is activated.

You may activate your new card by performing a PIN based transaction at an ATM or a merchant.

Your PIN is the same for your replacement card.



Account Ownership Alert!

Have you updated your account owners and payable-on-death (POD) beneficiaries?

If you have married, remarried, divorced, have children, or lost a loved one you should review your account ownership.

Payable-on-death beneficiaries cannot transact on your account. They receive the funds if all account owners have passed away.

Effective July 21st we have adjusted your new Leidos payroll deduction and associated allocations for the new biweekly payroll cycle.



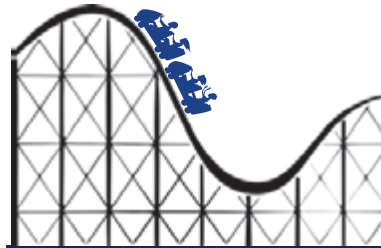
